



# AUTUMN 2023 HoCo CHEER INVITATIONAL



Howard County will host its Annual Autumn Invitational competition at **Howard High School** on **Wednesday, October 18, 2023**. This competition is open to Varsity and Junior Varsity teams and is sanctioned by the Maryland Public Schools State Cheerleading Committee (MPSSCC).

## Registration:

- Cost per team is \$150.00. **No REFUNDS** after October 4<sup>th</sup>
- ONLY the first **20 teams** to register will be guaranteed a spot!
- **Make school checks payable to Marriotts Ridge High School.**
- Only coaches on registration will be permitted to enter with the team during registration.

## Competition Guidelines:

- National Federation of High Schools (NFHS) and MPSSC Cheerleading rules and regulations will be followed including:
  - NO CELL PHONES are allowed in the cheerleaders holding area.
  - Athletes must wear their entire uniform for the duration of the competition.
- One panel of judges will be used unless we have a large sign-up, then we will use two panels.
- The length of the routine shall not exceed two and a half minutes and can be all music.
- Keep in mind that the team must still include a cheer portion that cannot be voiced over in the music and must be performed by the team on the mat.
- Up to 25 athletes are allowed on the mat
- Up to 25 people – coaches, mascots, managers, alternates, athletes – will be allowed to enter with the team.

## Event Information:

- The competition will be held in the main gymnasium of **Howard High School**.
- Routines will be performed on a non-spring cheerleading mat (42x42)
- Concessions and T-shirts will be sold.
- 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Place Team Trophies will be presented for each division.
- Team registration will begin at 4:00 pm. Open mat will begin at 5:00 pm.
- Doors will open to the public at approximately 5:30 pm.
- **The competition will begin at 6:00 pm**
- Cost of admission: \$5.00
